General Data Protection Regulation (GDPR) information clause

In accordance with Article 13 para. 1 and para. 2 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons in regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 /EC, General Data Protection Regulation, hereinafter referred to as "GDPR", we inform that:

- 1. The Administrator of your personal data is the "TEXTILCO" Marek Stasio with its registered office at ul. Łanowa 15/21, 91-103 Łódź, Polska, e-mail: textilco@textilco.pl, phone +48 42 611 07 10; NIP: 728-00-13-532, hereinafter referred to as ADO. The data administrator can be contacted via email: textilco@textilco.pl; or in writing at the address of the administrator's office with the note "Data protection".
- 2. Your personal data will be processed for the following purposes:
 - a) performance of contracts (pursuant to Article 6(1)(b) of the GDPR),
 - b) marketing of own products or services of the ADO (Article 6(1)(f) of the GDPR our legitimate interest is to provide information about our commercial offer,
 - c) implementation of our legitimate interest consisting in the possible determination or pursuit of claims or defense against claims (the legal basis for processing is Article 6(1)(f) of the GDPR).
- 3. Your personal data will be stored for the period necessary to achieve the purpose for which you consented. In particular, they will be processed for the duration of the offer or the duration of the contract, but no longer than for the duration of the contract, and in the case of consent until the consent is withdrawn. To the extent that the data is processed for the purpose of sending marketing content to you, it will be processed until you withdraw your consent or object to such processing. The period of personal data processing may be extended each time by the limitation period for claims, if the processing of personal data is necessary to pursue possible claims or defend against such claims by the ADO. After this period, the data will be processed only to the extent and for the time required by law, including tax and accounting law.
- 4. Your data will not be transferred to other entities except: the carrier or intermediary carrying out shipments on behalf of the ADO, suppliers of IT systems and IT services to the ADO, entities providing the ADO with services necessary to perform the contract concluded with you, including legal services, postal operators and couriers, banks for payment processing, certain persons practicing regulated professions, such as lawyers.
- 5. You have the right to: access the content of your personal data, including requesting a copy thereof and requesting its rectification, deleting personal data (the right to be forgotten), limiting the processing of personal data, the right to transfer personal data to another administrator, the right object to the processing of personal data, including profiling, and for direct marketing purposes, to withdraw consent if the ADO processes your personal data based on consent, at any time and in any way, without affecting

legality processing that was carried out on the basis of consent before its withdrawal. You have the right to lodge a complaint with the President of the Personal Data Protection Office if you believe that the processing of personal data violates the provisions of the GDPR.

- 6. You have the right to object to the processing of your personal data for the purpose of directing marketing content to you. In addition, you have the right to object to the processing of personal data for purposes arising from the legally justified interest of the ADO for reasons related to your particular situation.
- 7. Providing your personal data is voluntary, but necessary for placing and executing an order, concluding a sales agreement.
- 8. Your personal data will not be transferred to a third country or an international organization.
- 9. Your personal data will not be processed in an automated way and will not be profiled.
